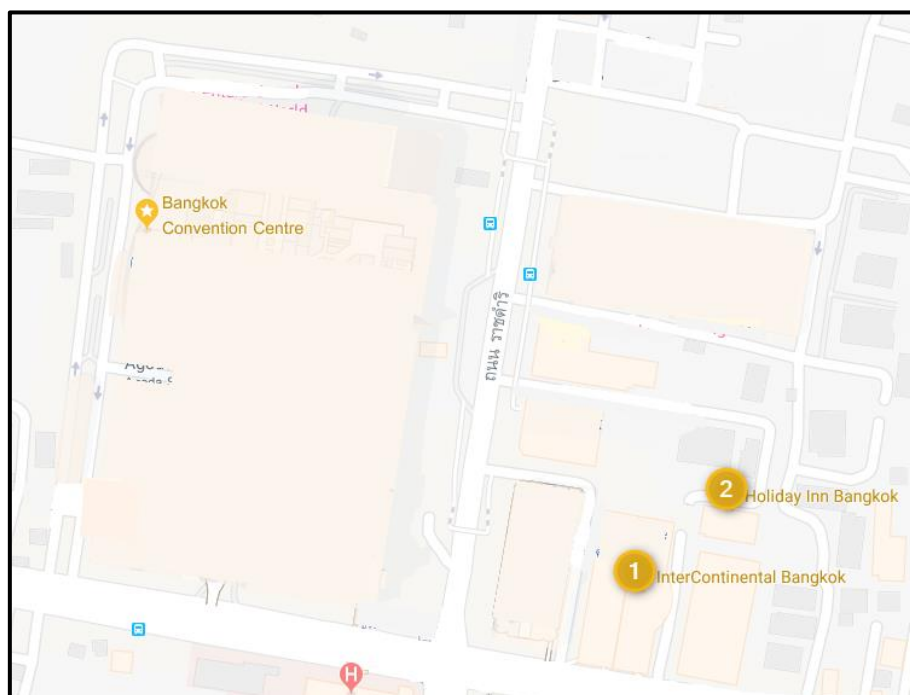
Hotel Accommodation

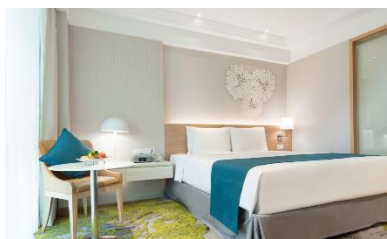

Hotel Booking Conditions (Groups)

Room Rates

All rates quoted are the lowest available for standard rooms during the period of the congress. Deposits are payable in USD and prices all include all applicable taxes. Breakfast is included, unless otherwise mentioned. All taxes are subject to change. Remaining payments and personal accounts are payable directly at the hotel in USD.

Reservation and Payment

For bookings of 10 or more rooms, in order to guarantee your reservation, the following deposit schedule is applied.

- 15% of total amount to confirm reservation
- 40% of the total reservation value before June 13, 2019
- 30% of the total reservation value before July 25, 2019
- 15% of the total reservation value before September 18, 2019
- 100% of the total reservation value must therefore have been paid by September 19, 2019

Payment by bank transfer is strongly recommended. All other payment methods are subject to a 4% service fee excluding applicable VAT. **As from 21.09.2019 only payment by bank transfer is accepted.**

Master Account and Credit Card Guarantee

It is understood that Client commits itself to pay the room (night)s stated in this contract. Hereto the Client will provide a credit card guarantee by completing the Credit Card Guarantee form attached to this contract. MCI will have the right to charge the amount, including a 4% service (excluding applicable VAT) for all payment methods other than bank transfer, if payments are not received within the stated deadlines, and will notify Client in case MCI intends to make use of this right.

If more rooms or an extension of a reservation are requested after this contract has been signed, these reservations will be subject to availability. Once this extra reservation request is honoured by MCI, a pro forma invoice will be issued, which will act as an addendum to this contract: once issued, conditions will apply as stated in this contract.

Non fulfilment of payment

Should we not receive the proof of payment on time, we will charge the credit card for the corresponding amount due (plus a 4% service fee, excluding applicable VAT) and as per general conditions. Failure to pay the required deposit(s) within the set deadlines of the payment schedule may result in the full cancellation of your reservation, with no refund of monies already paid. MCI will then invoice the corresponding percentage according to cancellation policy, by way of cancellation penalty. Please note that should you be eligible for a refund that these will be paid out after the congress. A finance charge of 1.5% per month will be applied to outstanding accounts beyond 30 days.

Potential additional costs, such as mini-bar and telephone, must be paid directly to the hotel upon check-out. Special requirements (as double room, twin room, smoking room) concerning the hotel rooms will be available upon request, and cannot be guaranteed.

Standard check in time at hotels is 15:00 hrs. Check-out time is 11:00 hrs. Should you need a guaranteed early arrival (before 15:00 hrs.) or a late departure (after 11:00 hrs.), an additional night is required to be booked and paid for.

Changes, No Shows and Cancellations

Any enquiries or requests for additional information, modifications or cancellations to room reservations should be addressed to MCI Amsterdam in writing (fax, letter or email). Please do not contact the hotel directly, as they will not accept any changes or cancellations made directly.

Cancellations are calculated on projected charges (per hotel, per night). In case of total or partial cancellation, refunds will be made according to the following schedule (less a 10% handling fee of the total value of the rooms released):

- From confirmation to June 13, 2019: 30% of the cancelled reservation value is non-refundable
- From June 13, 2019 to July 25, 2019: 50% of the cancelled reservation value is non-refundable
- From July 25 2019 to September 18, 2019: 80% of the cancelled reservation value is non-refundable
- From September 19, 2019: 100% of the cancelled reservation value is non-refundable

In line with the cancellation conditions, there will be no reimbursements for 'no show' guests.

MCI Amsterdam reserves the right to charge the full stay for cancelled rooms, cancelled nights or no-shows if the hotel room cannot be resold. In case of a no show, the hotel will guarantee your room until 11:00 hrs the day after your check in date.

A handling fee of USD 50 per hotel room will be charged for every hotel modification received after October 30, 2019.

Reference number and Hotel voucher

For your own convenience and to facilitate the reservation procedure, we kindly ask you to take note of your group number (including in your invoice) and refer to this number in all correspondence with the Housing Bureau. Please bring the hotel voucher with you, as it will serve as proof of your reservation at the hotel and deposit.
